Minutes of the parish council meeting held on Monday 9th September 2019 at 7.15pm at Galgate Recreation Rooms.

126/19 Apologies for absence.

127/19 Declaration of interests.

Cllr Helme and Cllr Booth declared an interest in any item relating to Ellel Village Hall as trustees.

128/19 Approve and sign the minutes of the parish council meeting held on Monday 8th July 2019.

129/19 Open forum.

Two residents, who are members of the Beech Avenue Playpark Committee, attended the meeting to ask the parish council if it would support a project to create facilities for teenagers in the village. The parish recreational area would be the only land that could be used. The committee members will ask the parish teenagers what they would like in the village and feedback to the parish council.

Erection of a single side storey extension. Spar, 71 Main Road, Galgate.

The parish council supports the application.

LCC/2019/0030

Proposed eastern lateral extension to the existing gritstone and shale quarry followed by infilling of the excavation with imported inert waste to be completed by the 30 June 2038, together with the rebuilding and extension of the derelict farmhouse for use as site office accommodation, with the

whole of the site to be finally restored by 30 June 2039, or within 12 months from the cessation of landfilling operations, whichever is the sooner. location: Ellel Crag Quarry, Ellel, Lancaster.

The parish council object to the planning application with the following observations:

The hydrology report states that the works would not have an impact on the residents in the area, but this was surveyed at only 500m out of the centre of the existing quarry, where there aren't any residential premises.

Going from the perimeter of the proposed extension, there are a number of bore holes and springs that feed water troughs in the fields. Some properties only have springs and no mains water.

The land off the side of the fell will have a change in the water course which will have an impact on homes and businesses.

The proposed extension is very close to residential boundaries. The two boreholes are 250 metres away from the boundary which puts the water sources under threat.

The stream is to be rerouted across the land to the north of the site which will affect the spring for livestock.

When the 8.5 hectares has been excavated the water runoff will be immense and this could pollute the fresh water, which is needed to be unpolluted for the animals and there is no guarantee of this being kept clear.

The current contractors do not have a good track record and have in the past breached their permits. They have previously been in threat of prosecution but managed to get this reduced to a negligible fine.

We are concerned that there will be no monitoring of what materials the quarry will be filled with when the wagons off load.

The quarry will be excavated 100 metres deep, this could have repercussions on the foundations of dwellings nearby.

What will the 1.79 million tonne of stone, which is not of good quality, be used for? There is nothing on the planning application that details the use for such a large quantity.

There is no consideration for the impact on the environment and wildlife. There are hares, deer and buzzards on the land with no reference to key species, making the impact statement outdated and flawed.

The change of use for the derelict house to offices will cause more traffic on the road at Star Bank. The track is a single use road with already existing vehicular access issues, with Five Lanes End already being a hot spot for accidents.

When they redirect the stream, which has not been referred to or considered in the application it will have to travel uphill across the gas pipeline. Also, there is an electric supply to be redirected that services adjacent properties.

The parish council object to the planning application as it is not necessary to extend the quarry and therefore no need to extend the timeframe.

Variation of condition 1 of planning permission LCC/2016/0001 to amend the time scale for the inert waste transfer and recycling operations, and the wood shredding/chipping operations, from 30 june 2023 to 30 June 2038 or within 6 months of completion of the landfilling activities at ellel crag quarry, whichever is the earlier, with restoration of the site within a further 12 months location: Ellel Crag Quarry, Ellel, Lancaster

The parish council object to the planning application as the extension to the quarry is not needed and the inert waste filling will not be able to be assessed or monitored daily. There could be waste materials that could be detrimental to the land if it leaches out on to farmland.

Cllr Whitaker has mended the fencing which was vandalised at the Galgate playpark.

134/19 To consider the replacement of benches and bins in the parish.

The clerk has contacted public realm and asked for the replacement bins but has had no response. It was resolved that two recycled plastic benches will be purchased for the village and one oak bench to be purchased in memory of Cllr Michael Helm and placed in Dolphinholme.
