Open forum

Issues raised during the open forum:

A question was asked regarding the toilets in the Recreation Rooms. The council agreed that the toilets may be moved around to create better storage for the rooms without cost. This would be done on a temporary basis to gauge the reaction of users of the rooms.

A question was raised regarding the recent proposal of a loan to the Ellel Village Hall. It was explained that Ellel Parish Council did not make a loan to the Village Hall.

A car had been apparently abandoned in Dolphinholme. Local councillors would investigate the matter further.

The handrail outside the Galgate Recreation Rooms had become unstable and unsafe. It was agreed that the Parish Council would seek quotes for the necessary repairs.

A question was asked regarding the missing seat at Dolphinholme. The Parish Council are in possession of a new seat that will be installed shortly.

A question was asked regarding the play area at Galgate Recreation Fields. The council are currently looking at the options available for the site and are hoping to have a solution to the current siting and condition of the play area soon.
