# Non-compliance with the accessibility regulations

Some images do not have a text alternative, so people using a screen reader cannot access the information. This fails WCAG 2.1 success criterion 1.1.1 (non-text content).

We plan to add text alternatives for all images by September 2023, When we publish new content, we'll make sure our use of images meets accessibility standards.

It's not always possible to change the device orientation from horizontal to vertical without making it more difficult to view the content.

We plan to address the device orientation issue by September 2023

It's not possible for users to change text size without some of the content overlapping.

We intend to address this issue by September 2023

# Content that's not within the scope of the accessibility regulations

PDFs and other documents

Some of our PDFs and Word documents are essential to providing our services. The accessibility regulations do not require us to fix PDFs or other documents published before 23 September 2018 if they're not essential to providing our services. For example, we do not plan to fix and minutes produced prior to this date.

Any new PDFs or Word documents we publish will meet accessibility standards.

**Live video** - We do not plan to add captions to live video streams because live video is exempt from meeting the accessibility regulations.

We used this approach to deciding on a sample of pages to test;

Pages are randomly selected for testing on an annual basis
